

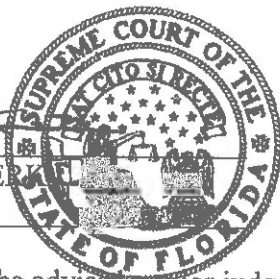
I, JORGE LABARGA, under authority vested in me as Chief Justice of the Supreme Court of Florida under article V, section 2, of the Constitution of Florida and the rules of this Court promulgated thereunder, do hereby assign and designate THE HONORABLE LEON M. FIRTEL, for statewide judicial service, effective April 23, 2015, and which shall expire on September 30, 2016. JUDGE FIRTEL is authorized to hear, conduct, try, and determine the causes which shall be presented to the judge as a temporary judge of any county, and circuit court in the State of Florida upon approval by the chief judge of that court and thereafter to dispose of all matters considered by the judge, including issues of fees and costs arising out of said causes, but excluding other matters subsequently raised that are collateral to said causes, during the term of this order. JUDGE FIRTEL, under and by virtue of the authority hereof, is hereby vested with all powers and prerogatives conferred by the Constitution and laws of the State of Florida upon a judge of the court to which the judge is assigned.
