WHEREAS, it is the intent of this court to purge from the records any Administrative Order or Amendment to an Administrative Order that is no longer in force, it is therefore,


ORDERED that the following local orders of general administrative application and/or amendments thereto are hereby terminated because the subject matter is obsolete or they have been replaced by newly filed orders:
