**Operating a Motor Vehicle without a Valid Insurance/Security**

Florida Statute 318.14(1) allows you to elect the option of entering a plea of 'Nolo Contendere' by providing proof of compliance with the appropriate statute to the Clerk of Court and paying the appropriate costs, adjudication will be withheld by the Clerk and no 'points' or 'conviction' will be assessed to your driving record by the DHSMV. You are only eligible for this option once every twelve(12) months and not more than three(3) times in your life time. If you sign this affidavit and are found to be 'ineligible' for this option, the DHSMV will suspend your License and you will be required to appear in court for sentencing.

**By entering a plea of Nolo Contendere in this matter you waive the right to a speedy trial, the right to an attorney, the right to question witnesses against you, the right to have witnesses testify on your behalf, the right to have the State of Florida prove charges against you and the right to file an appeal in this matter.**
